**Tim Blasl** is the President of the North Dakota Hospital Association, a not-for-profit trade association that represents North Dakota's hospitals. Mr. Blasl joined the association in 2008 and was appointed president in 2018. Mr. Blasl has over 28 years of healthcare experience. He provides leadership and guidance for members as it relates to advocacy and education. He also leads the association's affiliated entities, Hospital Services, Inc., the North Dakota Hospital Foundation, and the NDHA Health Benefits Trust. Mr. Blasl's experience includes 14 years with a hospital overseeing the revenue cycle operations for both the hospital and clinic. Mr. Blasl is a native of Bismarck, North Dakota. He earned a Bachelor of Science Degree from the University of Mary majoring in accounting and business administration.

**Senator Dick Dever –** District 32, Bismarck, has served in the North Dakota Senate since 2001. Senator Dever, a veteran of the U.S. Army, is retired. He serves on the boards of the Burleigh County Human Services Zone and PERS, he is the Chair of the Legislative Veteran's Caucus, is a Life Member and Judge Advocate with VFW Post 1326, and a Life Member and Commander of the AmVets Post 9. He serves on the following state interim committees: Budget Section, Human Services, Redistricting, and Retirement. During the 68<sup>th</sup> Legislative Assembly, he served on the full Appropriations, and Appropriations – Human Resources Division (Chairman) standing committees.

**Melissa Hauer** is General Counsel/VP of Advocacy at the North Dakota Hospital Association. Prior to joining NDHA, Melissa was in private practice in Washington and North Dakota, and she was previously the General Counsel for the North Dakota Department of Human Services, the North Dakota Insurance Department, and Sanford West. Melissa has a Bachelor of Arts degree from the University of North Dakota and a Juris Doctor degree from Gonzaga University School of Law.

**Johnathen Inskeep** is a seasoned healthcare IT leader with over 15 years of experience in cybersecurity, disaster planning, network administration, and implementing electronic health record (EHR) systems while ensuring compliance with healthcare regulations. Currently, Inskeep serves as a Security Strategist, working closely with customers and product teams to strengthen cybersecurity postures. Previously, he spent 9 years as the CIO at Caribou Memorial Hospital, overseeing all IT operations including network security, disaster recovery planning, staff training, project management, EHR implementation, and regulatory compliance. Prior to Caribou Memorial, Inskeep was the IS Director for Health Care Management LLC and Creekside Home Health and Hospice. In these roles, he managed network administration, disaster planning, training, project management, EHR implementation, and transition to Google Apps for Business. With his deep expertise in securing healthcare IT systems, mitigating risks, and maintaining regulatory compliance, Inskeep is a valued voice on the critical cybersecurity challenges facing the healthcare industry. His insights from years on the front lines will provide healthcare leaders with actionable strategies to bolster their organizational cyber resilience.

**Senator Judy Lee –** District 13, Fargo, has served in the North Dakota Senate since 1995. Senator Lee is a retired real estate broker and serves on the board for the Vocational Training Center, the Advisory Board for the Children Advocacy Center of ND, and the board for Eventide Senior Living. Representative Nelson is a retired farmer and serves on several local boards, including the American Cancer Society, Behavioral Health Champion Award, and the Consensus Council. In this role, she serves as the primary point of contact and representative of the AHA, the national organization that represents and serves all types of hospitals, health care networks and their patients and communities. This includes nearly 5000 hospitals and health care systems and more than 43,000 individual health care professionals that form the AHA. Region 6 is comprised of seven states: IA, KS, MN, MO, ND, NE, and SD. Liz strives to connect with all members in the region through personal visits, state association board meetings and conferences, virtual creative convenings, and AHA hosted events like the AHA Rural Leadership Conference, AHA Annual Membership Meeting, and other special events. In addition to representing the AHA in the field, Liz is a resource for members on policy and advocacy issues, often connecting members with AHA policy and advocacy resources and working to resolve policy related questions from members. Lastly, she works in concert with state hospital associations on member relations, advocacy, and policy development. On the policy front, Liz serves as the Secretary to the AHA Regional Policy Board – an AHA governing body comprised of members across Region 6 who meet regularly to assess and provide feedback on AHA policy. Liz joined the AHA in January 2020. Her career spans senior leadership roles in acute and outpatient care settings, legislative and executive branches of government, including the US Department of Health & Human Services, and several other nationally prominent healthcare associations working to support patient-centered heath care delivery and operational excellence. Liz has a particular passion for the role of hospitals in serving the diverse needs of their community regardless of setting (rural, urban, academic) and structure (system or free-standing, nonprofit or for-profit). Founded in 1984, *The Cook Political Report with Amy Walter* provides analyses of U.S. presidential, Senate, House, and gubernatorial races. *The New York Times* called *The Cook Political Report with Amy Walter* "a newsletter that both parties regard as authoritative." Wasserman analyzes the current political environment in lively and entertaining presentations that he can tailor to his audiences' specific interests or locales. His data-driven forecasting looks at both national and local trends (if requested, he can even do a district-by-district outlook), the relationship between consumer brand loyalty and voting, and what the future holds for American elections. Prior to joining the *The Cook Political Report with Amy Walter* in 2007, Wasserman served for three years as House editor of *Sabato's Crystal Ball*, a widely respected political analysis newsletter and website founded by renowned University of Virginia professor Larry Sabato.
