The information comes from the FORHP-supported [Flex Monitoring Team](#), a consortium of researchers evaluating the effectiveness of the Medicare Rural Hospital Flexibility Program.

The System of Care grant initiative is prioritizing the implementation of intensive home and community-based services, including intensive day treatment, care coordination, crisis services, and peer support.
