Content: Hospitals have become highly effective at detecting and managing C. difficile infection, yet many patients continue to experience cognitive, behavioral, and recovery challenges that are not explained by traditional models of infection. Emerging evidence demonstrates that Clostridia species beyond C. diff, when expanded in the gut after antibiotics or other disruptions, can produce neuroactive and inflammatory metabolites that influence systemic inflammation and brain function. This session provides a biologically grounded, clinically relevant framework for understanding how gut microbial disruption, particularly involving clostridia family organisms, affects mental status, behavior, and functional recovery in hospitalized patients.
